### **Public Hearing**

The application of Rose Watkins represented by Mike LoPresti for an area variance on an existing 6'4" fence of open construction on a deck at property located at 9 Hidden Trail, Spencerport, NY 14559. Whereas, any fence in a residential district shall not exceed three feet in height if erected at any point on the lot nearer the street than the front yard setback provided in this chapter and shall not exceed four feet in height if erected elsewhere on the lot pursuant to Chapter 340-32 A(1) in a residential district. Tax Account # 086.16-5-64.1

Mike LoPresti: I am here representing Rose Watkins for the fence variance. The primary reason for the fence is for privacy as these units are in close proximity to each other. They felt like it would be a nice buffer so that when they went out their door they wouldn't be staring directly to someone else. I apologize, did not realize that we had to have a variance for this. I looked at it a privacy fence rather than an actual fence. Patrick Smith brought it to my attention so I wanted to make this official.

Michael Flavin: Are you going to do this on all the units?

Mike LoPresti: Not all of units are going to have decks. I would say that it would be on an as needed basis. As this unit has one the unit next to it won't need a privacy fence.

Michael Flavin: Is the fence was vinyl or wood?

Mike LoPresti: It is vinyl railings with Azek material.
